### PRODUCT APPLICATION:

Spiced Chai is a beverage powder designed to be mixed with milk/water, ice and other flavourings. The beverage can be prepared hot, cold or using a blender or granita machine.

#### FLAVOUR:

Sweet, Mixed Spices, Black Tea, Honey, Dairy, Vanilla.

### **DIRECTIONS:**

#### Blender-

For 16oz/475ml Serving: Fill the cup with ice cubes, add water up to ¾ of the cup and pour into blender. Add 2 scoops (80g) of Spiced Chai. Blend at high speed for 30 seconds\* or until smooth. Decorate with whipped cream and toppings. \*Blender times will vary depending on blender type used.

#### Granita-

Add 1kg of Spiced Chai to 5L of cold drinking water and stir using a whisk. Transfer the liquid to a granita machine, leave on freeze with agitation on and wait until ice crystals have formed. Flavour and decorate as desired.

#### Over Ice -

For 16oz/475ml Serving: 1 scoop (40g) of Spiced Chai, add 220ml of cold drinking water/milk. Stir until fully dissolved and fill the cup with ice.

#### Hot

For 8oz/235ml Serving: 1 scoop (40g) of Spiced Chai, fill the cup with hot milk/water and stir until fully dissolved.
